Bids must be valid for a period of **90 (Ninety) days** after bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs: 4,75,000.00** which shall be valid for 30 days beyond the validity period of the bid.
